While you do not have to submit a quotation for all of the projects, the tender assessment will favour those quotations that can offer attractive prices through being awarded all projects.

Please note the following requirements and other pertinent information:

- Only quotations with complete information that are submitted to FIFA on or before the above deadline will be considered.
- All quotation prices must be in United States dollars.
- All proposals must be submitted in English.
- Please refer to each individual project in order to ascertain whether import tax is expected to be exempted.
- After the assessment of the construction sites, the bidder shall take full responsibility for the entire site conditions. If the bidder is not willing to do so, the proposal should address this matter.
- By participating in this tender, the bidder agrees to the legal considerations outlined in the "Football Turf Tenders – Legal Considerations" document provided.

FIFA reserves the right to stop the procedure of some or all of the proposed projects if the respective MA withdraws its interest or for any other reason, including but not limited to construction costs, implementation time or the number of quotations submitted.

A site visit must be arranged for each project. The contact details of the MA are included in the tender information.
